**Re: COVID-19 Reopening Guidance and Recommendations**

Thank you for your incredible sacrifice and patience as your business operations were altered or put on hold for the current COVID-19 pandemic. As we prepare to move into the multiple phases of reopening local businesses, the St. Mary's County Health Department wants to ensure all of our establishments have clear guidance on steps to open and operate their facilities safely.

The following provides guidance **for the time when such actions are allowable by state or local orders. This is only guidance and should not be misconstrued as an approval to reopen.**

These guidelines and recommendations have been developed by the National Restaurant Association and align with the FDA's *Best Practices for Retail Food Stores, Restaurants, and Food Pick-Up/Delivery Services During the COVID-19 Pandemic* guide.

As Maryland moves into each "Stage" of economic recovery outlined in Governor Hogan's [Roadmap to Recovery](#), there are multiple phases within each stage and local/regional specifications to consider. At this time please note:

**St. Mary's County residents and visitors should continue to wear face coverings or masks in indoor public places where they are exposed to others, including in retail locations and public transit.**

**St. Mary's County residents and visitors should continue to practice physical social distancing of 6 feet or more.**

**Restaurants and Bars – Reopening Preparation, Outdoor Seating Only**

Restaurants and Bars with Outdoor Seating may be allowed to reopen for customers seated in these outdoor spaces when allowed by state or local order. If you are interested in applying for a temporary expansion of your outdoor seating, please submit the attached application for consideration.

Restaurants and Bars without Outdoor Seating, when allowed to reopen by state or local order may reopen for customers seated in an approved temporary outdoor setting and would need to submit the attached application for consideration.

**If a State Executive Order allows reopening of restaurants at full capacity, the request to create or expand outdoor seating will require a different set of application review parameters.**

Outdoor seating may provide for an environment with lower risk of coronavirus disease transmission for employees and customers.

*Arrange and encourage curbside pick-up, drive-thru, and/or delivery options for your food service facility.*

Additional Considerations for when Outdoor Seating is allowed:

- Employees interacting with customers should continue wearing cloth face coverings or face masks during these interactions.
- Hand sanitizer must be available upon entry and exit for guests and employees, or hand washing facilities must be available.
- All employees must complete a health screening prior to their shift. Employees interacting with customers will be required to wear face coverings.
- All customers while waiting to be seated must follow appropriate physical distancing and face covering guidelines. If space does not allow for appropriate physical distancing, customers will be asked to wait in their cars or another off-premise area.
- Restricting table capacity to 6 people helps prevent large gatherings and associated risk of disease transmission.
- Physical distancing between tables must be at least 6 feet. If necessary, tables should be removed or clearly marked as not available for service to ensure they are not used if they are not safely spaced from other tables.
- Some outdoor activities have already reopened: Outdoor seating at golf courses, marinas and other outdoor venues to offer food and beverages may be allowed following the same guidelines above for restaurants and bars.
- Restaurants and bars that would like to expand upon their established outdoor seating capacity or establish new outdoor seating for dining, may use the attached application to submit a request. Each request will be reviewed to ensure that compliance has been met with all local ordinances, regulations, and safety precautions.

The St. Mary's County Health Department (SMCHD) Food Safety Program will continue with food safety education, inspection, and response to community public health complaints. Our team is available to work with yours in implementing the above strategies and others to minimize risk of disease exposure to your employees and customers.
